- · Carry out installation of surface cabling work
- Carry out work on low voltage armoured cables, and perform routine maintenance of Low Voltage (LV) AC motor
- Carry out connection work of fire alarm call point
- Carry out the sealing process for a certified conduit system
- Identify the considerations when installation of conduit in hazardous location
- Carry out cable disconnection to and re-connection from AC motor, re-lamping work, maintenance of batteries
